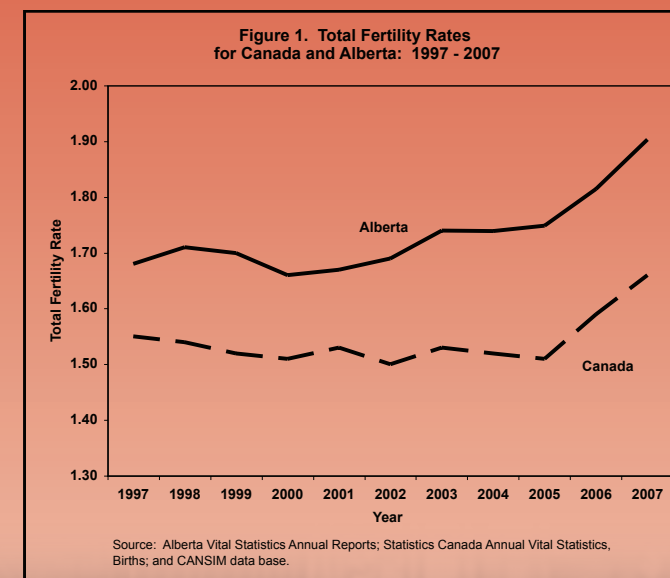

INFORMATION TO CONTRIBUTORS

Canadian Studies in Population has a broad interest in substantive and technical demography and related fields of study. While *Canadian Studies in Population* will continue to emphasize Canadian content, the editorial board encourages manuscript submissions from all sectors of the international community.

It is assumed that manuscripts submitted for review to *Canadian Studies in Population* have not been previously published and are not scheduled for publication elsewhere. Submission of a manuscript to other professional journals while that manuscript is under review by *Canadian Studies in Population* is unacceptable.

Preparation of Manuscripts

1. Mail one electronic copy of manuscripts to the Editor of *Canadian Studies in Population* at the following address: CanadianStudiesinPopulation@ualberta.ca
2. Manuscripts should not exceed 30 pages (including references), typed double-space on standard 8 1/2 by 11 inch white paper with wide margins.
3. The cover page is to include the title of the article, the author's name, an e-mail address and institutional affiliation. The author's name should *not* appear anywhere else in the body of the paper.
4. An abstract of 100 words or less should be provided on a separate sheet.
5. Three or four *key words* should appear immediately after the abstract.
6. Sub-topics or headings should be limited to two levels and referred to in the text by title rather than by number.
 - a. Each table should be typed on a separate page and numbered consecutively in Arabic numerals. Do not protect tables and/or figures.
 - b. Figures and graphs should appear on separate pages and numbered consecutively apart from the tables.
 - c. Originals of all tables, figures and graphs, in appropriate form for publication, will be requested by the Editor at the time a manuscript is accepted.
7. Reference style of citation should be used. Specify all references by last name of author and year of publication, with page numbers if appropriate. *Use Endnotes*, for citations and/or substantive comments.
8. Include a double-spaced alphabetical list of references with full publication information and without any abbreviations.
9. Acknowledgments are to be included in a section at the end of the main part of the text.
10. Authors of accepted manuscripts will be asked to supply electronic spreadsheets of their data tables and figures for copyediting and formatting purposes.
